INSTRUCTION FOR POSTER PRESENTATION GUIDELINES

• Poster Size & Layout

Use the standard poster size (usually 3 ft × 4 ft or A0) with a clear, readable layout—including title, authors, affiliation, introduction, methodology, results, conclusion, and references.

• Font & Readability

Ensure all text is easily readable from a distance: title (90–120 pt), headings (60–80 pt), and body text (28–40 pt). Use simple fonts like Arial, Calibri, or Times New Roman.

• Visual Quality

Use high-resolution images, graphs, and tables. Keep visuals clean, well-labeled, and directly relevant to the research. Avoid overcrowding with excessive text.

• Content Clarity

Present information in a logical flow with bullet points or short paragraphs. Highlight key findings and avoid complex jargon. Ensure all data presented is accurate and properly cited.

• Presentation & Mounting

Bring your printed poster to the venue on time and mount it on the assigned soft board as per the schedule. Authors must remain present during the poster evaluation session.

INSTRUCTIONS FOR ORAL PRESENTATION

• Presentation Duration

Each presenter will be allotted 8 minutes for the presentation, followed by 2 minutes of interaction/Q&A. Please adhere strictly to the time limit.

• Slide Format

Prepare your slides in PowerPoint (PPT/PPTX) format with clear headings, readable fonts, high-quality visuals, and minimal text. Avoid overcrowded slides.

• Content Structure

Your presentation should include: Title, Authors & Affiliation, Introduction/Background, Objectives, Methodology, Results, Conclusion, and References. Highlight key findings clearly.

• Technical Submission

Submit your final presentation to the technical team at least 1 day before your session. Ensure compatibility and check your file during the preview session to avoid technical issues.

• Delivery & Professionalism

Speak clearly. Stay within the allotted time and be prepared to answer questions from judges and delegates.

AWARDS AND RECOGNITION

Competitions will be conducted separately for UG, PG, and PhD students in both poster and oral presentation categories. Note: Certificates will be issued only to the presenting author. The decision of the Scientific Committee shall be final.
